## AICG CONSULTATION DRAFT 63 ('CD63') CIVIL AVIATION (CARRIERS' LIABILITY) ACT 1959 – AUSTRALIA

In Q3 2021, AICG received a request from a market participant to consider the legislative references found within AVN57A (Australia). Specifically, it was suggested that the reference to 'Civil Aviation (Carriers' Liability) Act 1959' be considered in light of the Aviation Legislation Amendment (Liability and Insurance) Act 2020, which came into effect on Thursday 17th June 2020.

The AICG considered the request further and agreed that this administrative update to the clause to account for the 2020 Act would be necessary. It sought expert advice and concluded that it would be appropriate to refer to both the Civil Aviation (Carriers' Liability) Act 1959 and the Aviation Legislation Amendment (Liability and Insurance) Act 2020, jointly termed within the clause as 'The Acts'.

This clause has been considered by the full AICG membership and the Chair has agreed that it proceed to market consultation forthwith. The draft clause is attached to this letter for convenience, in addition to a tracked change version highlighting the updates when compared to AVN57A (Australia), and will also shortly be added to the AICG website, accessible via this hyperlink: AICG Activity.

We would welcome comments on the proposed clause – both on the specific drafting and its effect as appropriate. AICG consultation drafts are normally subject to 30-day consultations, however, in light of the busy December period for market participants, the AICG Chair has agreed a 45-day consultation period.
