Claims Handling Challenges & Underwriting Considerations

- Lack of Breakdown in Repair Estimates
- Lack of Co-Operation From Some Repairers
- Longer Repair Periods Means Higher Costs
- Lack of Alternative Repairers
- Fixed Labour Rates in Policies
- Repair Costs at Inception Can Be Significantly Higher in 11 Months Time
- Increased Adjuster Fees.
- Inflation
